

Any Institution that offers courses or programs designed to lead to Professional Licensure or certification or advertised as leading to Licensure must satisfy all federal requirements for disclosures regarding such Professional Licensure programs under 34 §C.F.R. 668.43, effective July 1, 2020. The following table discloses whether Bon Secours Memorial College of Nursing's (BSMCON) Pre-Licensure BSN Program curriculum satisfies the state professional board's requirements as well as those of the District of Columbia, Puerto Rico, and the U.S. Virgin Islands, so that a graduate of the institution is eligible to be licensed in that state or territory (which may require state board approval of the program curriculum/content).
